(A) The main aims and objectives of the trust are:-

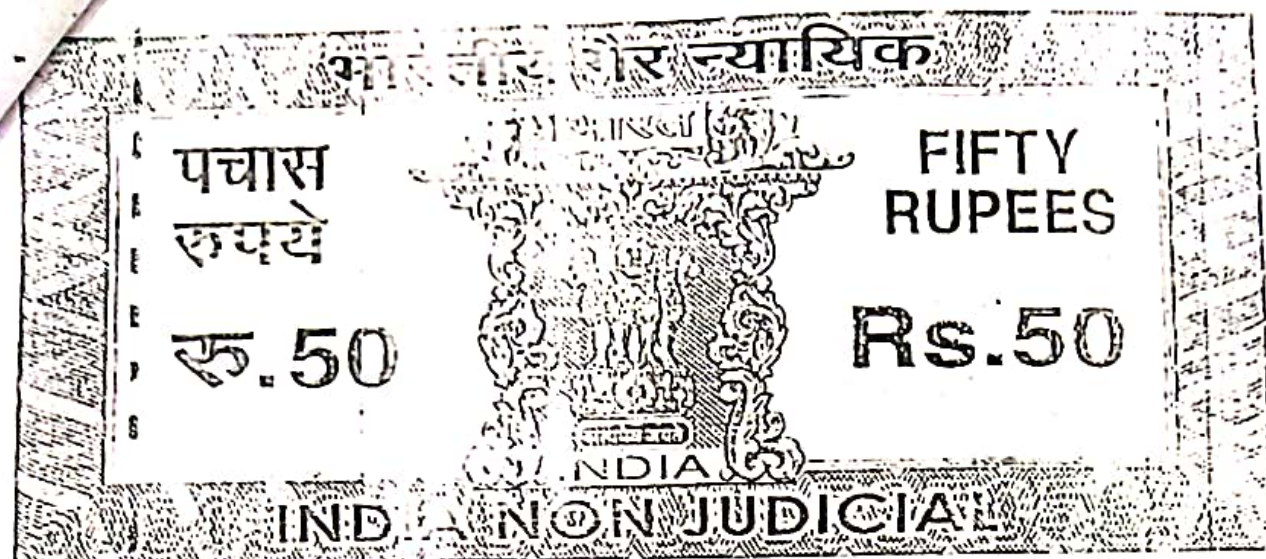

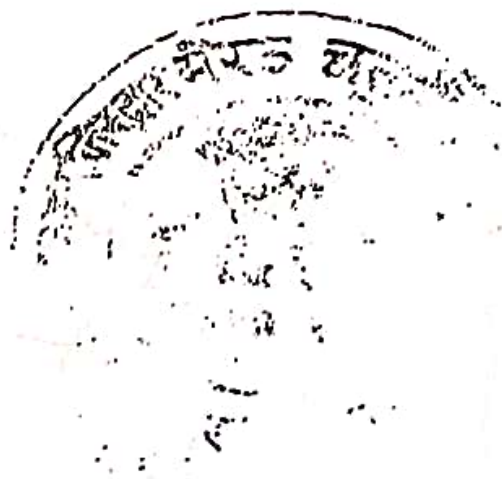

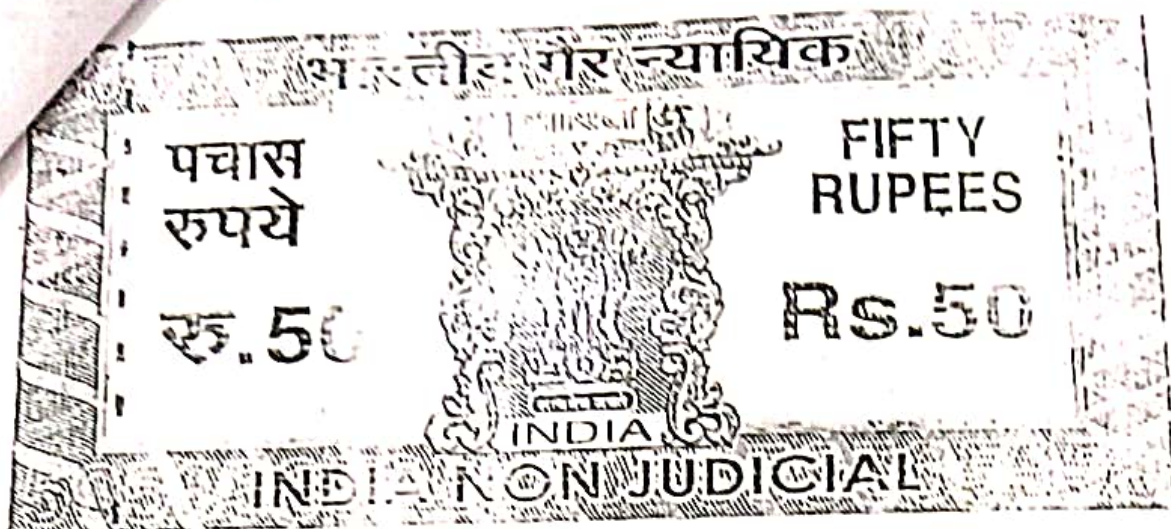

- (g) To buy, sell, endorse, negotiate or transfer all Government or other securities and to collect and realize interest, bonus, dividend or profits on such securities for its objectives.
- (h) To invest and deal with its funds and moneys in securities, shares, debentures or bonds or elsewhere and to sell or transfer such investments from time to time or in property and to operate its accounts with any bank, bankers or sheriffs etc. upon such terms and conditions and such manner as may from time to time be determined or deemed expedient or as defined in the trust deeds of account.
- (i) To lend or otherwise employ money belonging to it, to borrow or raise money with or without security by mortgaging or debenture or charging the whole or any or any part of its property, assets or rights and on such terms and conditions as may be determined from time to time.

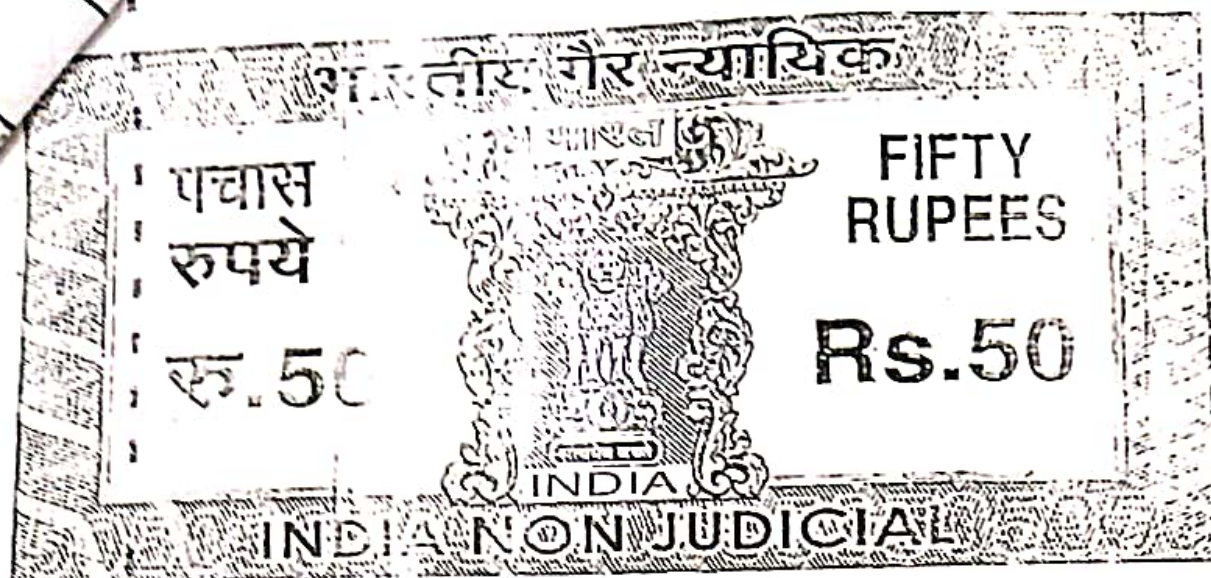

5.1.1B In case of death of Chairman Trustee or secretary trustee the founder trustees/board of trustees will elect or nominate the next Chairman or next Secretary of the trust in place of the founder trustees in future.

5.1.1C Secretary Trustee with the consent of the chairman trustee can nominate & can ask to remove up to any two general members or on seniority basis to work with the board of trust but at any point or aspect before appointing them or after appointing, the decision of chairman will be the final decision.

5.2 VACANCY OF OFFICIAL.

5.2.1 In Case of death of any Founder trustee, the vacancy shall be filled by the heir as per the will of the said trustee, in case will is made in the favour of more than one person, only one person in representative capacity and in case there is no will than as per law of succession, however right of succession shall be available to only one person amongst the legal heirs with the consent of all the legal heirs.

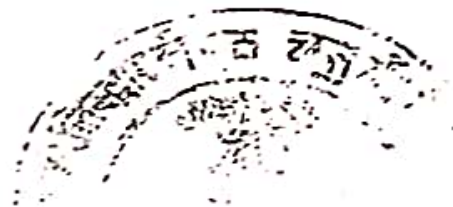
5.2.2 Any Trustee of the foundation desiring to resign from membership of the foundation, may do so by sending a request letter in writing to the Board of Trustee, who may accept the same and such acceptance shall be subject to the approval by the Board of Trustee of the Trust.

6. FINANCE

The donations and profits, income and property of the trust will be applied solely for the

promotion of the objectives of the trust, as set forth above, and no portion thereof shall be

paid or transferred directly or indirectly in the form of dividends, bonus or otherwise to soever in the form of profit to any member or ex-member or

any other person claiming through them or any of them, provided that nothing contained shall prevent in good faith the payment of

remuneration for any services rendered to the trust but the chairman trustee & Secretary trustee can receive the payments for their working expenses

from trust, that working expenses amounts will be decided, renewed & watched by the board of trust.

7. MANAGEMENT

The management and control of the trust shall vest in the Board of trustees of the trust, the power & duties vested in it in the said deed.

8. POWER AND DUTIES

8.1. POWER AND DUTIES OF THE BOARD OF TRUSTEES

8.1A. The Board of the Trustees shall have full powers, and authorities of acts, matters

thing and deeds, which may be necessary or expedient, for the purpose of management of the trust subject to final approval of the Chairman Trustee.

8.3A. The Board of Trustees may alter, modify, rescind (redefine or redesign) or add the rules, regulation and bye laws by two third majority in the meeting duly convened for this purpose.

8.4A. To do all things for the purpose of effectively carrying out the objectives and activities of the trust.

8.5A. To constitute sub-committee consisting of the persons from outside and/or among Trustees with such powers and functions as the Board of Trustees may deem fit, with the consent of chairman trustee.

8.6A. To look after and supervise the management of the properties and activities of the trust and to spend money for that purpose.

8.7A. To fix fees or charges in respect of different activities of the trust and the manner in which the same is to be received.

8.8A. To fix, increase or decrease the rent of the property belonging to the trust.

8.9A. To keep any person in service or expel or terminate the person from service of the trust for misconduct or for any act, which in the opinion of the Board of Trustees, is prejudicial to the interest of the trust, provided that no such action should be taken without giving opportunity to the person concerned of being heard.

8.10A. To invest funds in Banks, or shares, debentures or bonds or elsewhere and to sell or transfer such investments from time to time for the benefit of the trust.

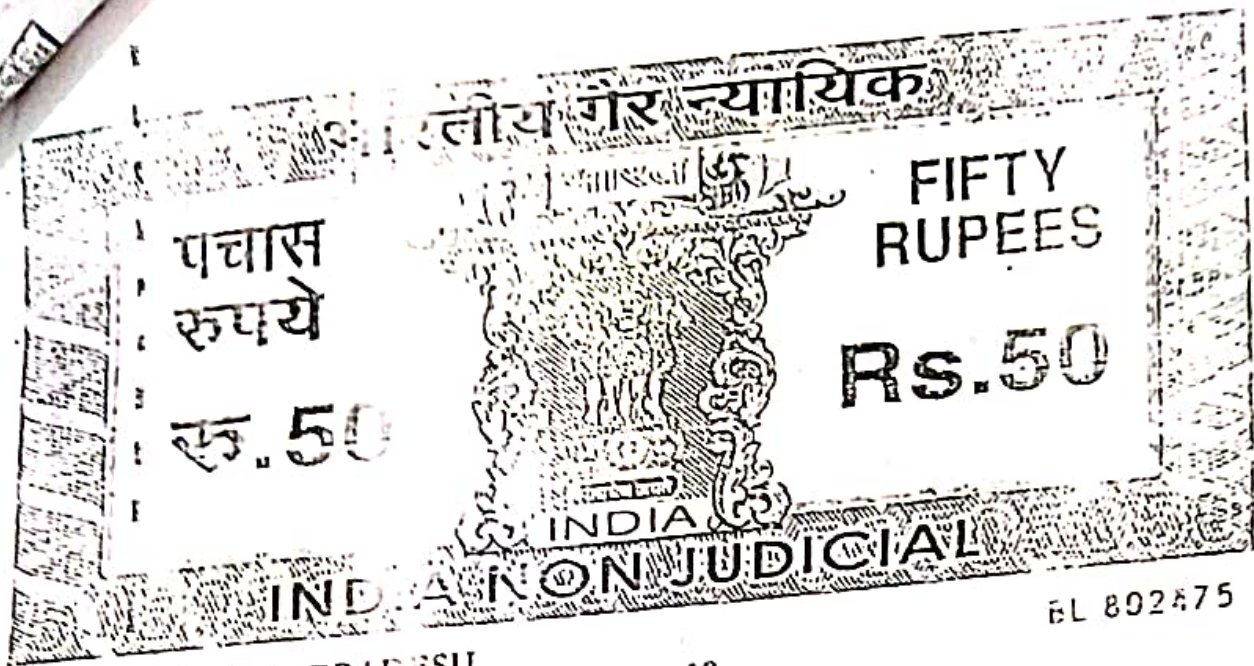
8.11A. To invest funds to acquire movable and immovable properties either by way of purchase, gifts, donation, mortgage, lease, grant or license.

8.16A. To sue, defend and conduct any civil or criminal proceedings and to compromise, withdraw, give up or abandon any claim on behalf of the trust for all purposes, to incur necessary expenses from the funds of the trust.

8.17A. To defend institute or take any legal proceedings for the defence of office bearers, employees or members of any body or committee of the trust if such legal action has arisen during the course of their action for the interest of the trust.

8.18A. To defend, institute of trust can take any legal proceedings against any employee or anybody and during such legal proceedings against any employee or anybody and during such legal action, for the interest of trust to compromise or abandon any such claims and incur necessary expenditure from the funds of trust.

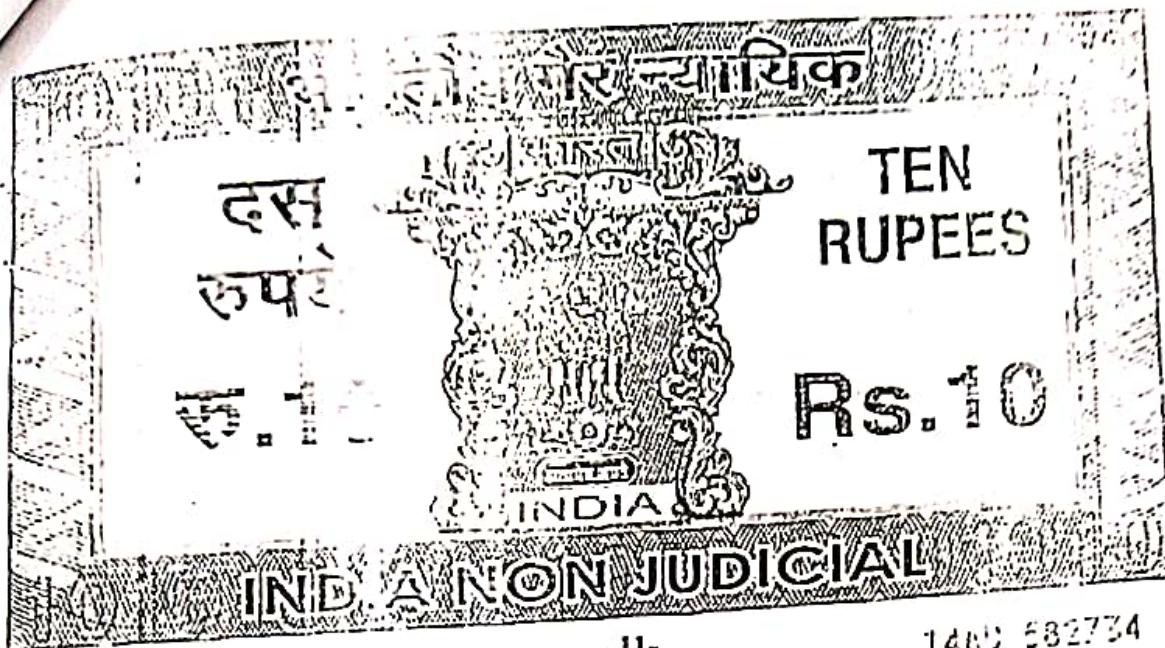
8.19A. To execute on behalf of the trust all contract, conveyance or all sort of documents and to receive and accept the same.

- 8.30A. To alter, modify and adopt new aims and objectives of the trust, which shall be passed by two third majority of the trustees in a meeting duly convened for the purpose.
- 8.31A. To delegate any power/powers to a Trustee or any other person as Board of Trustee of the trust may think proper.
- 8.32A. Chairman Trustee shall be the executive head of the trust to carry out the management of the property of the trust. Chairman Trustee shall exercise such powers, as provided in these Rules and Regulation.

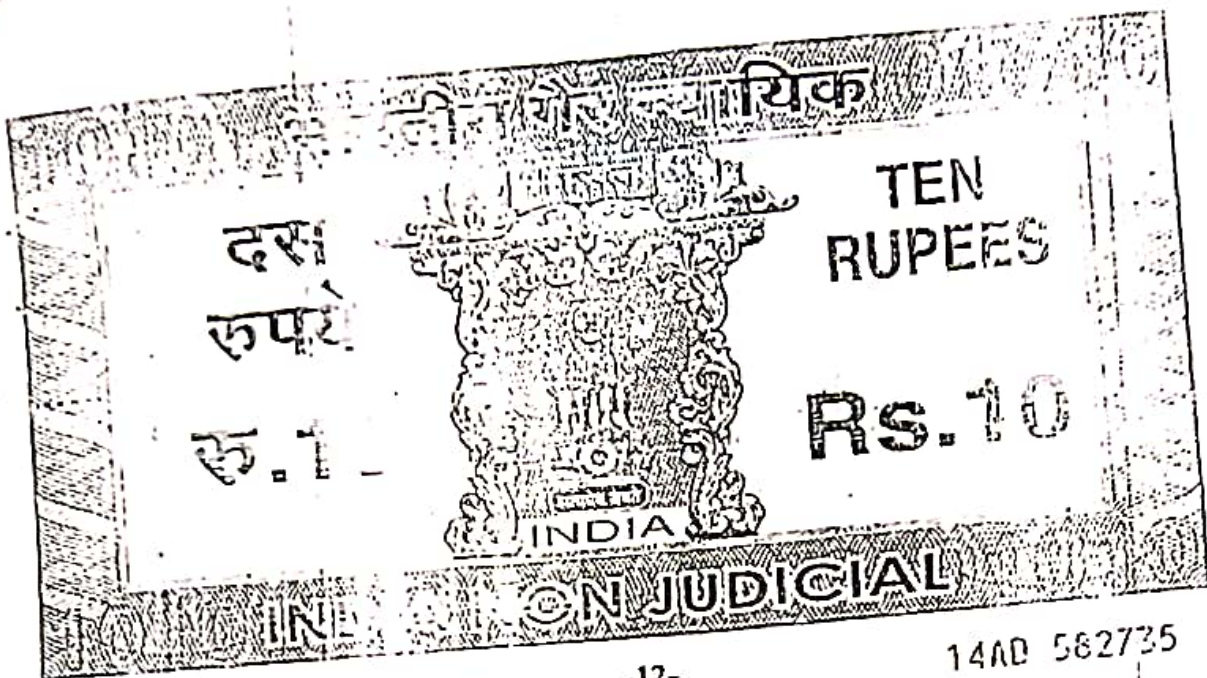

10.4 The Annual Accounts shall be audited by duly appointed Chartered Accountant.

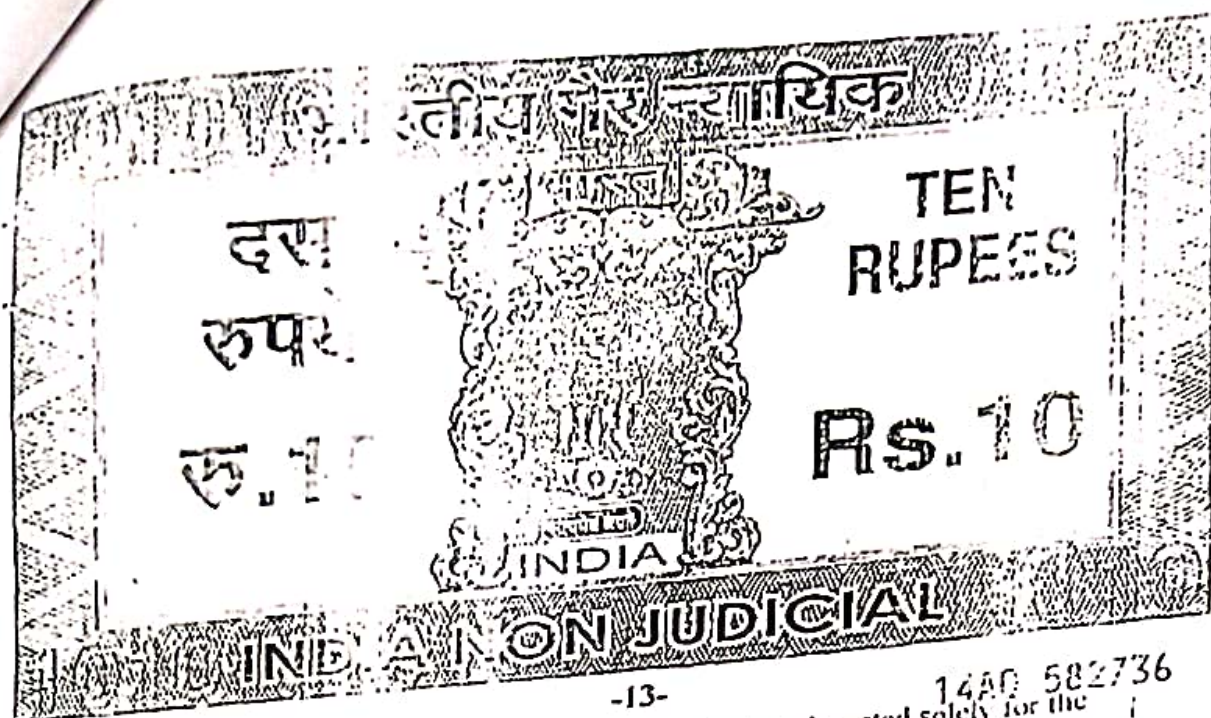
11. FUNDS

11.3 All Banking Accounts in any bank & any other financial account of any type anywhere shall be operated upon by the chairman & secretary trustee jointly.

12. QUORUM

For a meeting of Board of Trustees, there, shall be a quorum of at least one third of total.

When a meeting cannot be held for want of quorum, the same shall be adjourned for one hour and two members present shall form a quorum for such adjourned meeting.

13. NOTICE OF MEETING

13.1 Notice in writing of every meeting of the Board of trustees shall be delivered or sent through post or by hand or by the possible way to all the Trustees of the Trust at their addresses on record, at least three clear days before the date of the meeting.

13.2 The chairman/Trustee may call an extraordinary meeting of the trust for which a notice of 24 hours or as he/she think best in the interest of trust before the date of the meeting shall be deemed sufficient.

14. LIABILITY

14.1 The members of the Board of Trustees shall be liable only for such moneys and securities as they shall actually receive not withstanding their signing any receipt, for the sake of conformity and shall not be answerable or responsible for the acts, receipts, omissions, negligence and defaults of any banker, broker, auctioneer or there person with whom or into whose hands and money or securities shall be deposited and other losses, unless the same have happened through their own negligence, default or admission, breach of trust, misapplication or misconduct.

14.2 That in case of borrowings the liability of each Trustee existing in future will continue till the loan amount taken by trust from the bank.

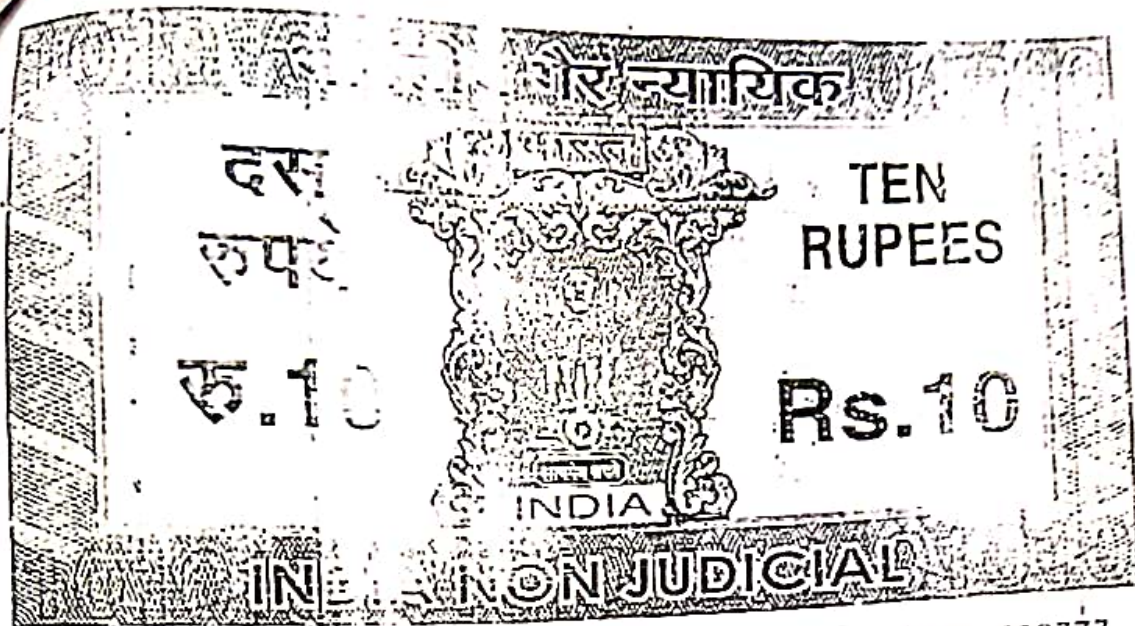
